# Principles applied in data processing

In the treatment of your personal data, the Owner will apply the following principles that comply with the requirements of the new European data protection regulation:

- **Principle of legality, loyalty and transparency:** The Owner will always require consent for the processing of his personal data, which may be for one or more specific purposes, about which he will previously inform you with absolute transparency.
- **Principle of minimization of data:** The Owner will request only the data strictly necessary for the purpose or purposes requested.
- **Principle of limitation of the conservation period:** The data will be kept for the time strictly necessary for the purpose or purposes of the treatment.

The Owner will inform you of the corresponding conservation period according to the purpose. In the case of subscriptions, the Holder will periodically review the lists and eliminate those inactive records for a considerable time.

- **Principle of integrity and confidentiality:** Your data will be treated in such a way that your security, confidentiality and integrity are guaranteed. You should know that the Owner takes the necessary precautions to prevent unauthorized access or improper use of the data of its users by third parties.

## Obtaining personal data

## Your rights

The Owner informs you that you have the right to:

You have the right to effective judicial protection and to file a claim with the supervisory authority, in this case, the Spanish Agency for Data Protection, if you consider that the processing of personal data concerning you violates the Regulation.

## Purpose of the processing of personal data
